



Muskogee Farmers' Market (MFM)

Membership Application Form

VENDOR INFO (Please read first):

1. Muskogee Farmers Market is a “PRODUCER ONLY” market, which means you must grow, produce, or process the products that you would like to sell. While limited reselling is allowed to offer a broader range of farm products to our customers, it is limited to 20% of what a vendor may bring on any given market day. No multi-level marketing or mass-produced and branded items are allowed.
2. Please note that space is limited. Vendors selling fruits and vegetables, meat, eggs, and other farm products will be given priority consideration, especially those that are organic or grow fruit, mushrooms, or something else unique.
3. It is a vendor’s responsibility to know what permits, licenses, and certificates are required. Information about required permits and licenses for each product category can be found in our guidelines.
4. The MFM management team reviews all new applications. Acceptance of new vendors into the Market is at their complete discretion. If your application is accepted, you will be contacted by the market manager.
5. Application Deadline: new vendors can send in an application any time, but it should be received before March 1 for best consideration. Vendors applying during the market season may not receive consideration that year if spaces are limited. At a minimum, they should expect to wait at least two weeks before being able to sell.
6. Non-Profit Groups: Typically, non-profit groups are not permitted to become vendors. Please contact the market manager for more information.
7. You are responsible for your own tables, chairs, etc. Your booth must show the name and address of your farm or business.
8. Annual Membership Dues: \$50; due at the pre-season meeting or before your first sale day
9. Stall Fees (paid at the end of each market day):
 - a. Saturday single space: \$20 or 10% of total sales (10% option available only if sales are counted and reported exactly)
 - b. Saturday double space: \$30 (limited number available)
 - c. Wednesday single or double space: \$15 or 10% of total sales
